Achievements and performance	<ul> <li>The Acting Group Scout Leader's report covers the activities and achievements of Section members. The Group continues to be in demand and has expanded numbers as far as possible, given the number of leaders. The Group Executive Committee met formally five times during the year.</li> <li>A planning application has been submitted for improving the yard at the Albany Mews entrance, providing disabled parking and cycle</li> </ul>	
	<ul> <li>parking.</li> <li>There has increased regular use of the building during the daytime, when not needed for section meetings.</li> <li>Motion sensitive lights have been fitted in the toilets to avoid lighting being left on between meetings.</li> <li>New internal doors have been fitted and the existing doors re-used to enclose the roof space above the Albany Mews entrance.</li> <li>The rainwater downpipe at the river end of the building has been repaired, meaning that the damp problem in the staircase has been fixed.</li> <li>The wooden gig <i>Alert</i> has had a number of planks and other woodwork replaced and is now watertight.</li> <li>A temporary boat storage rack has been erected in the yard to accommodate infrequently used boats during the Winter, to free space in the Boat Deck.</li> <li>Broken tiles on the roof have been replaced, along with sealing of the ridge tiles.</li> <li>Members' subscription payments have been thoroughly audited and anomalies sorted out.</li> </ul>	
	The annual safety check in January and regular safety reports revealed no significant problems.
